**[PROPOSED] ORDER AUTHORIZING
RELEASE OF REMAINDER OF
ATTORNEYS' FEES**

1 WHEREAS, on December 8, 2022, plaintiffs Wei Huang and Langdon Elliott (“Lead
2 Plaintiffs”) and additional plaintiff Ani Hovhannisyan (collectively, with Lead Plaintiffs, “Plaintiffs”),
3 through their counsel at Hagens Berman Sobol Shapiro LLP and Scott+Scott Attorneys at Law LLP
4 (together, “Plaintiffs’ Counsel”), moved for an order pursuant to Federal Rule of Civil Procedure 23
5 for an award of attorneys’ fees and litigation expenses (ECF No. 256);

6 WHEREAS, on January 25, 2023, the Court awarded as attorneys’ fees a sum equal to 25% of
7 the Settlement Amount, plus \$99,468.65 in litigation expenses (both amounts to be paid from the
8 Settlement Fund), together with any interest thereon for the same time period and at the same rate as
9 that earned on the Settlement Fund until paid pursuant to the terms set forth in the Stipulation, but
10 subject to a hold-back provision (ECF No. 274 at 2);

11 WHEREAS, 10% of the attorneys’ fees granted at final approval were withheld until after the
12 Post-Distribution Accounting has been filed and the Court has authorized the release of those funds;
13 and

14 WHEREAS, Plaintiffs filed the Post-Distribution Accounting on January 10, 2025;

15 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that:

16 1. This Order incorporates by reference the definitions in the Stipulation and Agreement
17 of Settlement, dated as of July 27, 2022 (ECF No. 224-2) (the “Stipulation” or “Stip.”), and all
18 capitalized terms used, but not defined herein, shall have the same meanings as those set forth in the
19 Stipulation.

20 2. Plaintiffs’ Counsel are authorized to take payment of the remaining 10% of the awarded
21 attorneys’ fees (plus interest), such funds having been hereby released.

22 IT IS SO ORDERED.
